He received his formal education in the Harrisburg School District. Thereafter, he served honorably in the United States Army from 1960 to 1962. of his eighty-fifth birthday), Lawyer passed from labor to reward joining in eternal life his parents; and his brothers and sisters, Leon Mitchell, Helen Palmer, Earl Mitchell, Richard Mitchell and Marie Saunders.
